ROBERT APPELBAUM is Professor of English Literature at Uppsala University, Sweden and Fellow of the Stellenbosch Institute for Advanced Study, South Africa. His most recent book is *Working the Aisles: A Life in Consumption* (2014).

LOUIS ARMAND directs the Centre for Critical and Cultural Theory in the Philosophy Faculty of Charles University, where he also edits the international arts magazine *VLAK*. He is the author of ten collections of poetry and six novels.

He is completing two manuscripts, *Ahumans and Reified Life: Flotsam and Jetsam within Neoliberalism* and *Just in Time Education: Industrializing Thought in the Age of Big Data*.

DANIEL T. O'HARA is Professor of English and Inaugural Mellon Professor of Humanities at Temple University. He is the author/editor/co-editor of fourteen books, including most recently *Narrating Demons, Transformative Texts: Rereading Genius in Mid-Century Modern Fictional Memoir* (2012).

KENNETH J. SALTMAN is Professor of Educational Leadership at University of Massachusetts Dartmouth. He is the author of numerous books on the cultural politics and political economy of education including most recently *The Politics of Education: A Critical Introduction* (2014), *The Failure of Corporate School Reform* (2012), *Toward a New Common School Movement* with Alex Means and Noah DeLissovoy (2014), and *Neoliberalism, Education, Terrorism* with Jeffrey Di Leo, Henry Giroux, and Sophia McClennen. He has received two American Educational Studies Critics Choice Book Awards and a Fulbright Chair on Globalization and Culture.

NATHAN SNAZA teaches modern fiction, critical theory, and educational foundations at the University of Richmond. He is co-editor of *Posthumanism and Educational Research* (2014), and his essays have appeared or are forthcoming in journals including *Angelaki*, *LIT: Literature Interpretation Theory*, *Cultural Critique*, *Journal for Critical Animal Studies*, and *Journal of Curriculum and Pedagogy*. He is currently co-editing, with Asimina Karavanta, a forthcoming issue of *symplokē* on posthumanisms.

MICHELLE TY is a doctoral candidate in the departments of Critical Theory and English at the University of California, Berkeley.

HAROLD ARAM VEESER is Professor of English at City College of New York and Professor in the Middle East and Middle Eastern American Center of the Graduate Center, CUNY.
