Notes on Contributors

Elly Cockx-Indestege was formerly Keeper of the Rare Book Department in the Koninklijke Bibliotheek, Brussels. Her research interests range over early printed books, bookbinding in the Low Countries, the reconstruction of the book collection formed by the Duke of Arenberg in the nineteenth century, and an inventory of the productions of the bookbinder Berthe van Regemorter.

Jason Peacey is a Senior Research Fellow at the History of Parliament Trust. He is the author of *Politicians and Pamphleteers: Propaganda in the Civil Wars and Interregnum* (Ashgate, 2004), and he has edited *The Regicides and the Execution of Charles I* (Palgrave, 2001) and co-edited *Parliament at Work* (Boydell, 2002). He is currently preparing a monograph entitled *Print Culture and Political Participation in Britain, 1640–1660*.

Duncan Wu is Professor of English Language and Literature in the University of Oxford and Tutorial Fellow of St Catherine's College. He is the editor of *Selected Writings of William Hazlitt* (9 vols, Pickering & Chatto, 1998), and he is currently writing a biography of Hazlitt.

ONLINE ACCESS TO THE LIBRARY

The Library is now also available in online format, from Oxford University Press, via the web address <http://www.library.oxfordjournals.org/>. Access to the electronic version comes at no extra charge to members of the Bibliographical Society, and is available to those non-member subscribers who have opted for the combined print and online, or online-only, subscription rates.

Earlier volumes have also been converted to electronic format, and members of the Society now have free access to the complete back run of the journal, which reaches back to the late nineteenth century. Current subscribers via Oxford University Press have electronic access back to 1996.

BIBLIOGRAPHICAL SOCIETY LIBRARY

The Society's library, housed at Stationers' Hall EC4 7DD (tel. 020 7248 2934) is normally open on Mondays and Tuesdays, 10.30 a.m. to 4 p.m., but

members of the Society are advised to telephone in advance to make sure that the Hon. Librarian, Robin Myers, or the Stationers' Company's Hon. Librarian, Keith Fletcher, is in attendance. Members may borrow from the Society's library and are welcome to work in the Stationers' library which includes London livery company and book-trade history which usefully supplements the Society's own collection.

The Society is pleased to announce that the catalogue of its library is now available electronically, via the catalogue of the School of Advanced Study at the University of London (<http://www.lib.sas.ac.uk>). The new catalogue, containing 3,883 records, can be searched from any computer with web access. Users can search by title; author; keyword; subject; author/title combination; classmark; or ISBN. Browsing is also available. Hyperlinks enable maximum retrieval: for example, following a subject search, it is possible to click on the classmark to find other works at the same classmark and hence on the same subject, which, if peripheral, may not have its own subject heading. The main value of the project is of course for members of the Bibliographical Society, but the records should also be useful to a wider circle of users. Greater awareness of the contents of the Society's library can only be welcomed. The fact that books available for reference purposes elsewhere are borrowable from the Society's library makes it of particular value to members of the Society.

BIBLIOGRAPHICAL SOCIETY GRANTS

Minor grants

The Fellowships and Bursaries sub-committee of the Bibliographical Society offers small grants of £50 to £200 throughout the year for specific purposes such as travel expenses or the cost of microfilming. Applications for such grants may be submitted on the appropriate form at any time, and should be supported by one referee and a statement that funds are not available from other sources. If the applicant is registered for a research degree, the application should be accompanied by a letter of support from his or her academic supervisor.

Support for student attendance at conferences

Conference organizers are invited to apply at any time during the year for up to £250 in order to support the attendance costs (e.g. travel, accommodation, and conference fee) of one or more postgraduate students (maximum per student £125). The application for these Bibliographical Society Studentships should take the form of a letter explaining the relevance of the conference to the Society's interests, the dates and location of the conference, the structure and content of the programme, and the costs to the students that are to be covered.

FUNDRAISING APPEAL FOR ST BRIDE PRINTING LIBRARY

The St Bride Printing Library, which covers the historical, artistic and technical aspects of printing and related trades from the earliest times to the present day, and which houses unique typefaces, trade artefacts, and printing presses as well as books, is the subject of a new fundraising appeal. It has been short of funds since April 2004, when the Corporation of London transferred ownership of and financial responsibility for the library back to its original guardian, the St Bride Foundation. The appeal for funds, in the shape of the Foundation Benefactor scheme (launched jointly by the St Bride Foundation and the Penguin Group), aims to raise awareness of the Library's urgent need both for immediate funding and for long-term financial support, so that it can continue as a vital resource for leading practitioners and students of typography and design. THE SOCIETY'S PUBLICATIONS POLICY

The Council of the Bibliographical Society has approved the following statement of the Society's interests, with the particular intention of providing guidance to authors of monographs who may be considering publishing with the Society:

The Bibliographical Society promotes and encourages publications in historical, analytical, descriptive, and textual bibliography. The scope of these has widened in recent years to include the making and use of manuscripts, the history of printing, publishing, and illustration, the study of book-binding, the history of the book, as well as the history of libraries and the study of provenance, readership, and book collecting. The Society's publications relate to every part of the world and to all periods.

The following eight subject categories provide some specific examples of areas of interest:

1. Biographical dictionaries of the book trade.
2. Analytical or historical studies of aspects of the book and the book trade.

3. Studies of libraries and collections of bibliographical consequence, with introductions.
4. Facsimiles and editions of items of bibliographical interest, with introductions.
5. Manuscript, palaeographical, and textual studies.
6. Marks in books, including provenance studies.
7. Studies of books as physical objects (binding, structure, paper, methods of printing, processes of illustration, etc.).
8. Bibliographical handbooks; bibliographical theory and methodology.

BIBLIOGRAPHICAL SOCIETY GRANTS

The Society is pleased to announce that, as a result of the thirteenth competition for the research grants set up with funds received towards its centenary appeal, the following awards have been made:

- \$1500 from the Bibliographical Society of America, as the Fredson Bowers award, and an additional £993 from the Bibliographical Society, London, to Carter Hailey for a description and analysis of watermarks from the hand-press period;
- £2000, as the Falconer Madan Prize (and in association with the Oxford Bibliographical Society), to Nicholas Fisher for bibliographical work on John Wilmot and Robert Whitehall;
- £500 from the National Trust, as the Royal Oak Award, and an additional £1338 from the Bibliographical Society, to Tania Colwell to study the Mélusine fragments at Upton House;
- £1434 to Rupert Ridgwell to work on Mozart's Viennese music engravers, the award associated with the name of the Antiquarian Booksellers Association;
- £1100 to John B. Hench to work on the internationalization of the US Book Trade, 1942–1948, the award associated with the name of Barry Bloomfield;
- £1739 to Bill Bell for a study of nineteenth-century continental tourists and their books;
- £286 to Sharon Brown for a study of selling, collecting, and reading French books in eighteenth-century Scotland;
- £1260 to Jean-François Gilmont for a bibliography of sixteenth-century French-Swiss editions.

Applications for grants to be awarded in February 2007 should be submitted by 1 December 2006 and should be supported by letters from two referees familiar with the applicant's work. A limited sum is also available from time to time for minor grants of £50 to £200 to be awarded on a year-round basis. An Early London Printing House at Work:
Studies in the Bowyer Ledgers

by Keith Maslen

These collected pieces grew out of the prolonged study of a major London printing house during its flourishing life from 1699 to 1777, that of William Bowyer father and son. They explore the internal operation of the business, its regular dealings with the trade in London and further afield (especially Dublin), and, by means of its innumerable relations with a surprising variety of authors and clients, its outreach to society at large.

Many particular questions are pursued. How often was the 'copy' divided and shared among multiple printers? What more can be known about some of those others, notably Samuel Richardson, William Strahan, and George Faulkner in Dublin? What was the relation of jobbing printing to book production? How many copies of a novel or poem were commonly printed?

Problems in the bibliography of Pope, Swift, Defoe, Gay, Holinshed, Berkeley, and others are explored, using the collateral evidence of the printers' ledgers and other business records, published in 1991 as *The Bowyer Ledgers*.

These studies of authorship, book production, and distribution—now brought together, revised, extended, reset in Caslon type, and indexed—are augmented by a supplement to Maslen's *The Bowyer Ornament Stock* (1973), an appendix on the Bowyer-Emonson partnership, and 'Bowyer's Paper Stock Ledger', by Herbert Davis. They offer a wide-ranging and timely contribution to the history of the book in Britain, as well as the foundation for further exploitation of the Bowyer records by bibliographers, historians, and others.

Many of the papers in this volume originally appeared in The Library, and are reprinted with permission. MAURIZIO FIORILLA

MARGINALIA FIGURATI NEI CODICI DI PETRARCA

Il libro prende in esame le note di lettura figurate vergate nei margini dei manoscritti della biblioteca di Francesco Petrarca. Nella prima parte del volume sono analizzati i segni di attenzione (graffe e *maniculae*) che caratterizzano il sistema di annotazione petrarchesco e le piccole figure con cui Petrarca era solito incorniciare alcune sue postille. Altre pagine sono dedicate a interventi di dubbia autografia o riferibili ad intellettuali con cui Petrarca era in stretto contatto (Landolfo Colonna, Ildebrandino Conti, Giovanni Boccaccio) e ad anonimi lettori trecenteschi. Nella seconda parte sono invece riesaminati alla



luce di nuovi elementi i disegni marginali, sulla cui paternità si è aperto nella seconda metà del secolo scorso un vivace dibattito tra chi vi ha riconosciuto la mano di Boccaccio e chi invece ha continuato, come avevano fatto gli studiosi della fine dell'Ottocento e della prima parte del Novecento, ad assegnarli a Petrarca. Chiudono due appendici dedicate ad approfondimenti su questioni strettamente collegate ai disegni: il problema dell'erronea attribuzione a Claudiano di un'origine fiorentina e la discussa paternità boccacciana dei *marginalia* vergati in un codice cassinese con le *Antiquitates Iudaicae* di Giuseppe Flavio.

The marginalia added by medieval and Renaissance readers to their texts frequently included figurative elements such as Notabene signs, pointing hands and actual small drawings. This volume analyses the manuscripts owned by Petrarch and the system of signs used by him in his annotations, including the small figures he often used to frame his notes. Also studied are similar marginalia in manuscripts from the library of Boccaccio and of other 14th-century intellectuals in Petrarch's circle.

Maurizio Fiorilla (Roma 1972) è attualmente professore a contratto di Filologia della Letteratura Italiana presso la Facoltà di Lettere e Filosofia dell'Università degli Studi di Roma Tre. Nella sua attività di ricerca ha indagato soprattutto la ricezione dei classici nelle opere di Petrarca e Boccaccio a partire dallo studio dei codici postillati dai due scrittori (argomento su cui ha pubblicato alcuni saggi). Vincitore nel 1997 per la miglior tesi di laurea del «Premio Boccaccio» e nel 2004 per la miglior tesi di dottorato del «Premio Sapegno», collabora inoltre continuativamente dal 1997 con recensioni alla «Rassegna della Letteratura italiana» (sezione Trecento).
