

Gillian Arrighi is a Lecturer in Drama in the School of Drama, Fine Art and Music at the University of Newcastle, Australia. She worked for many years as a theatre performer and now teaches acting, devising performance, and theatre histories. Recent research publications have appeared in *Theatre Journal* (December 2008) and *Australasian Drama Studies* (April 2009 and October 2010). Her current research interests include children on the stage, popular entertainments of the Victorian and Edwardian eras, and animals in performance. She is the associate editor of the recently launched e-journal, *Popular Entertainment Studies*.

Paul Arthur studied at the University of Western Australia and held research fellowships in Europe, North America and Australia before taking up the position of Deputy Director of the National Centre of Biography and Deputy General Editor of the Australian Dictionary of Biography, Australian National University.
