## **Biographies of Contributors**

**Edward Anders** (Alperovitch) was born in Liepāja, Latvia, and survived the Holocaust by posing as a half-Jew. He received a Ph.D. in chemistry from Columbia University in 1954. From 1955 to 1991 he served on the faculty of the University of Chicago, where he was Horace B. Horton Professor in the Department of Chemistry and the Enrico Fermi Institute. He is a member of the U.S. National Academy of Sciences and has received many other professional honors. Dr. Anders recently edited and revised the English translation of Josifs Steimanis's 1995 *History of Latvian Jews* (2002).

**Lawrence Baron** is Abraham Nasatir Professor of Modern Jewish History and Director of the Lipinsky Institute for Judaic Studies at San Diego State University. He is author of a biography of the German-Jewish anarchist Erich Mühsam and coeditor of three anthologies, including (with Pearl and Samuel Oliner) *Embracing the Other: Philosophical, Psychological, and Historical Perspectives on Altruism* (1992). He is writing a book about the Holocaust depictions Holocaust in recent feature films.

**Juris Dubrovskis** is working on his master's degree in political science at the University of Latvia in Riga. From 1999 to 2001 he worked as Edward Anders's research assistant, gathering material in the Latvian State Historical Archives.

**Alexander Victor Prusin** is Assistant Professor of History at the New Mexico Institute of Mining and Technology. His articles include "The Russian Military and the Jews in Galicia, 1914–1915," in Eric Lohr and Marshall Poe, eds., *The Military and Society in Russia, 1450–1917* (2002); and "Revolution and Ethnic Cleansing in Western Ukraine: The OUN-UPA Assault against Polish Settlements in Volhynia and Eastern Galicia, 1943–1944," in Hunt Tooley and Steven Vardy, eds., *Ethnic Cleansing in Twentieth-Century Europe* (Columbia University Press, forthcoming). Dr. Prusin was 2001–2 Charles H. Revson Foundation Fellow at the Center for Advanced Holocaust Studies of the United States Holocaust Memorial Museum. He is working on a monograph entitled *The Holocaust in the Generalbezirk Kiev*, 1941–1943.

**Timothy E. Pytell** is at California State University, San Bernardino. His article "The Missing Pieces of the Puzzle: A Reflection on the Odd Career of Viktor Frankl" appeared in the *Journal of Contemporary History* (April 2000). He is working on a biography of Frankl entitled *Paradoxical Intention: Viktor Frankl's Struggle for Meaning*.

**Dariusz Stola** is a fellow at the Institute for Political Science, Warsaw; Professor of History and Deputy Rector at the Collegium Civitas, Warsaw; and a fellow at the Center for Migration Research, Warsaw University. His publications include: *Nadzieja i zagłada: Ignacy Schwarzbart—żydowski przedstawiciel w Radzie Narodowej RP*, 1940–1945 (1995); *Kampanja antysjonistyczna w Polsce* 1967–1968 (2000); ed., with Claire Wallace, *Patterns of Migration in Central Europe* (2001); and numerous occasional pieces on the Holocaust, on international migration, and on the Polish communist government.

**Anton Weiss-Wendt** studied modern European history at Tartu University, Estonia. In 1997 Mr. Weiss-Wendt received his M.A. in Judaic studies from New York University. He is currently a Ph.D. candidate at Brandeis University, where he is writing a dissertation on the Holocaust in Estonia. Mr. Weiss-Wendt has worked on comparative genocide studies and Stalin's terror. He has published in *Holocaust and Genocide Studies*, the *Journal of Baltic Studies*, and *Nationalities Papers*.
