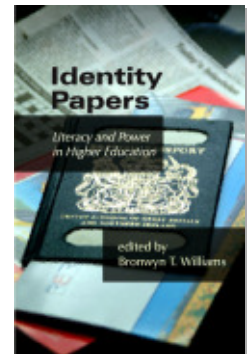

## CONTRIBUTORS

BRONWYN T. WILLIAMS is an associate professor of English at the University of Louisville. He writes and teaches about issues of literacy, identity, popular culture, and cross-cultural communication. His books include *Tuned In: Television and the Teaching of Writing* and *Popular Culture and Representations of Literacy* with Amy A. Zenger. He also writes a column on issues of literacy and identity for the *Journal of Adolescent and Adult Literacy*.

JANET ALSUP is an associate professor of English education at Purdue University. In addition to articles and book chapters, she has written two books, *But Will it Work with Real Students? Scenarios for Teaching Secondary English Language Arts* and *Teacher Identity Discourses: Negotiating Personal and Professional Spaces*.

SALLY CHANDLER is an assistant professor of English at Kean University where she teaches college composition. Her research interests include the study of communication across difference, and the exploration of ethnographic and feminist methods for collaborative research. Her work has appeared in *Feminist Teacher*, *Generations*, and *Oral History*.

BIANCA FALBO is an assistant professor of English and assistant director of the College Writing Program at Lafayette College. Her scholarship focuses on the institutionalizing of literacy practices since the turn of the nineteenth century in a range of cultural sites including school books, periodicals, editions of “literary” texts, and student writing. PATRICIA HARKIN teaches English and communication studies at the University of Illinois, Chicago. She is author of *Acts of Reading*, editor of a special issue of *Works and Days* celebrating the work of Richard Ohmann, and co-editor of *Configuring Virtual Worlds: Teaching with Virtual Harlem* and *Contending with Words: Composition and Rhetoric in a Postmodern Age*. Her work has appeared in *College English*, *College Composition and Communication*, *Rhetoric Review* and she has served on the executive committees of the National Council of Teachers of English, the Conference on College Composition and Communication, and the Society for Critical Exchange.

MIN-ZHAN LU is Professor of English at the University of Louisville, where she teaches courses in composition, life writing, critical theory, and the pedagogical uses of cultural dissonance. Her most recent book is *Shanghai Quartet: The Crossings of Four Women of China*. She is recipient of the Mina P. Shaughnessy Award for Best Article Published in the *Journal of Basic Writing* for her essay “Redefining the Legacy of Mina Shaughnessy,” and her essay “An Essay on the Work of Composition: Composing English Against the Order of Fast Capitalism” won the 2004 Richard Braddock Award.

JAMES R. OTTERY is an assistant professor of English at the University of Illinois at Springfield. Besides his work in composition and rhetoric, he also teaches American Indian literature and the writing of poetry. Maritza is graduating from Dennison University in May 2006.

TARA PAULINY earned her PhD in rhetoric and composition from The Ohio State University in 2002. Her work focuses dually on feminist and queer rhetorics and writing center and writing program administration studies. She is currently an assistant professor at the University of Wisconsin–Oshkosh where she also directs the university’s writing center.
