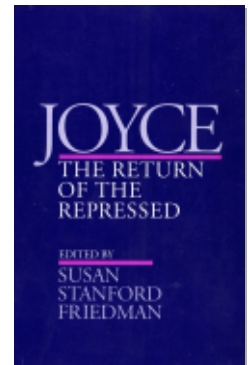

Notes on Contributors

JOSEPH A. BOONE is Associate Professor of English at the University of Southern California. He is the author of *Tradition Counter Tradition: Love and the Form of Fiction* (1987) and co-editor, with Michael Cadden, of *Engendering Men: The Question of Male Feminist Criticism* (1990). He is at work on two books, one on issues of sexuality and narrative in modern fiction (of which this essay is a part) and the other on the homoerotics of Orientalism in narratives of the Near East.

MARILYN L. BROWNSTEIN is Assistant Professor of English at the University of Georgia. She has published articles on postmodern theory, neuroscience and gender, Marianne Moore, Plato's *Phaedrus*, and Joyce's *Finnegans Wake*. She is completing a book, *Postmodern Strategies: Cognitive Dialectics and the Dimensions of Difference*, and is co-editing a volume of essays on politics and cognitive linguistics.

JAY CLAYTON is Associate Professor of English at Vanderbilt University. He is the author of *Romantic Vision and the Novel* (1987), *Narrative and Power: Writing in a Multicultural Society* (1993), and co-editor of *Influence and Intertextuality in Literary History* (1991). He has published on nineteenth-century poetry and fiction and on literary theory and the contemporary novel. He is at work on a book titled *The Genealogy of Postmodernism*.

LAURA DOYLE is Assistant Professor of English at Harvard University. She is completing a book titled *Bordering on the Body: Racial Patriarchy, the Mother Figure, and Modern Fiction*, which combines anthropology, history, and philosophy to explain the narrative innovations and the sexuo-racial matrix of modern experimental fiction. She has also written about Jean Toomer, Virginia Woolf, and Toni Morrison.

SUSAN STANFORD FRIEDMAN is the Virginia Woolf Professor of English and Women's Studies at the University of Wisconsin-Madison. She is the author of *Psyche Reborn: The Emergence of H.D.* (1981), *Penelope's Web: Gender, Modernity, H.D.'s Fiction* (1990), co-author of *A Woman's Guide to Therapy* (1979), and co-editor of *Signets: Reading H.D.* (1990). She has published articles on narrative theory, feminist criticism, women's poetry, autobiography, modernism, psychoanalysis, childbirth metaphors, gender and genre, and women's studies. She is at work on *Portrait of an Analysis with Freud: The Letters of H.D., Bryher, and Their Circle, 1933–1934* and *Return of the Repressed in Modernist Narratives*.

CHRISTINE FROULA, Professor of English at Northwestern University, is the author of *A Guide to Ezra Pound's Selected Poems* (1983), *To Write Paradise: Style and Error in Pound's Cantos* (1984), and *Joyce and Woolf: Gender, Culture, and Modernity* (1993). She has published numerous articles on feminist theory and modern literature, and is working on a book, *Women and Western Literature: Tradition and Transformation*.

ELLEN CAROL JONES is Assistant Professor of English at Purdue University and Managing Editor of *Modern Fiction Studies*, for which she has edited the special issues *Feminist Readings of Joyce* (1989), *Virginia Woolf* (1992), and *The Politics of Modernism* (1992) and co-edited the special issue *Feminism and Modern Fiction* (1988). She has published essays on Joyce and Woolf and is completing *Writing the Other: Joyce's Ulysses*, a book on *Ulysses* read through feminist, poststructuralist, and postcolonial theories. She is also editing a collection, *Joyce: Feminist Studies*.

ALBERTO MOREIRAS is Assistant Professor of Spanish at the University of Wisconsin-Madison. He is the author of *La escritura política de José Hierro* (1987) and *Interpretación y diferencia* (1992). He has also published articles on contemporary Latin American fiction and literary theory. He is currently at work on a book on aesthetics and mourning in Hispanic fiction.

RICHARD PEARCE is Professor of English at Wheaton College in Massachusetts. He is the author of *The Politics of Narration: James Joyce, William Faulkner, and Virginia Woolf* (1991), *The Novel in Motion: An Approach to Modern Fiction* (1983), and *Stages of the Clown: Perspectives on Modern Fiction from Dostoyevsky to Beckett* (1971). He has published essays on modern fiction, modern drama, science and literature, film and literature, and teaching *Ulysses*. He is the editor of *Critical Essays on Thomas Pynchon* (1981) and *Molly Blooms: A Polylogue on "Penelope" and Cultural Studies* (1994).

ROBERT SPOO is Assistant Professor of English at the University of Tulsa, where he is also editor of the *James Joyce Quarterly*. He edited the first publication of H.D.'s *Asphodel* (1992) and co-edited *Ezra Pound and Margaret Cravens: A Tragic Friendship, 1910–1912* (1988). He has published articles on Joyce, Pound, H.D., and other modern writers and is completing a book-length study of historiographic narrative in Joyce's *Ulysses*.
