

ABOUT THE AUTHORS

LAURA ABRAMOVSKY is an independent economic consultant and researcher, and a research associate at the Institute for Fiscal Studies (IFS) in the United Kingdom. She has more than fifteen years of experience in microeconomic research and public policy evaluation. Her current work focuses on tax and social protection policy and program and impact evaluation in developing countries. She is one of the founders of the IFS's UK Department for International Development-funded Centre for Tax Analysis in Developing Countries (TAXDEV). This program aims at generating new research, analysis, and in-country analytical capacity in the area of tax and benefit policy and administration in a range of developing countries. She obtained her Ph.D. in economics from University College London.

JAMES ALM is Chair of the Department of Economics at Tulane University. Previously, he was Regents Professor in the Department of Economics at the Andrew Young School of Policy Studies at Georgia State University in Atlanta, Georgia, where he served as chair of the department and dean of the school.
