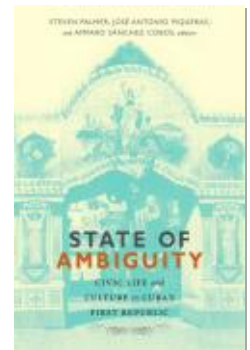

Imilcy Balboa Navarro is associate professor at Universitat Jaume I, Castellón, Spain. Alejandra Bronfman is associate professor at the University of British Columbia. She is the author of *On the Move: A Recent History of the Caribbean since 1989* (2007) and *Measures of Equality: Social Science, Citizenship, and Race in Cuba, 1902–1940* (2004), and coeditor of *Media, Sound, and Culture in Latin America and the Caribbean* (2012). She is currently involved in the book project *Talking Machines: Caribbean Media and Publics*, which explores the perambulations of objects in empires in the early twentieth century, with particular attention to new media including telegraph, telephone, and broadcasting and their relationships to capital flows, imperial projects, and regional political mobilizations.

Maikel Fariñas Borrego is a PhD student at the University of North Carolina at Chapel Hill and a former researcher at the Instituto de Historia de Cuba. Author of *Sociabilidad y cultura del ocio: Las élites habaneras y sus clubes de recreo (1902–1930)* (2010), he has also published several articles focused on sociability and leisure in Cuba, including “El asociacionismo náutico en La Habana: Desde las élites hasta las capas populares (1886–1958)” (2010), and “Las asociaciones de recreo del tipo ‘yacht club’ y su papel en el trazado socio-urbanístico de La Habana (1920–1958)” (2008).

Reinaldo Funes Monzote is research director at the Fundación Antonio Núñez Jiménez de la Naturaleza y el Hombre, Havana, and assistant professor at the University of Havana. He is the author of *El despertar del asociacionismo científico en Cuba, 1876–1920* (2004), and *From Rainforest to Cane Field in Cuba: An Environmental His-*

tory since 1492 (2008), the Spanish version of which won Cuba's Premio Catauro and Premio de la Crítica and the UNESCO Prize for Caribbean Environmental Thought.

Marial Iglesias Utset is an independent scholar and former associate professor at the University of Havana. The Spanish edition of her book, recently published in English as *A Cultural History of Cuba during the U.S. Occupation, 1898–1902* (2011), was awarded the Clarence H. Haring Prize of the American Historical Association, the Annual Prize of the Cuban Academy of Sciences and the Instituto del Libro, and the Essay Prize of the Union of Artists and Writers of Cuba (UNEAC).

Steven Palmer is Canada Research Chair in History of International Health and associate professor at the University of Windsor, Canada. He is the author of *Launching Global Health: The Caribbean Odyssey of the Rockefeller Foundation* (2010) and *From Popular Medicine to Medical Populism: Doctors, Healers, and Public Power in Costa Rica, 1800–1940* (Duke University Press, 2003). He has coedited with Iván Molina *The Costa Rica Reader: History, Culture, Politics* (Duke University Press, 2005), with María Silvia Di Liscia and Gilberto Hochman *Patologías de la Patria: Enfermedades, Enfermos, y Nación en América Latina* (2012), and with Juanita De Barros and David Wright *Health and Medicine in the Circum-Caribbean, 1800–1968* (2009).

José Antonio Piqueras Arenas is chair of contemporary history at the Universitat Jaume I, Castellón, Spain. He is the author of several books focused on Cuban and Caribbean history, including *Trabajo libre y coactivo en sociedades de plantación* (2009), *Félix Varela y la prosperidad de la patria criolla* (2007), *Sociedad civil y poder en Cuba: Colonia y poscolonia* (2006), and *Cuba, colonia y comercio: La disputa de un mercado interferido (1878–1895)* (2003), and has coedited with Imilcy Balboa *La excepción americana: Cuba en el ocaso del imperio continental* (2006).

Ricardo Quiza Moreno is a professor of history at the Casa Fernando Ortíz in Havana and a former researcher at the Instituto de Historia de Cuba. He is author of *El cuento al revés: historia, nacionalismo y poder en Cuba (1902–1930)* (2003), *Embajada de España en La Habana, Antiguo Palacio Velasco Sarrá* (2008), and *Imaginarios al ruedo: Cuba y los Estados Unidos en las exposiciones internacionales (1876–1904)* (2011).

Amparo Sánchez Cobos is assistant professor at Universitat Jaume I, Castellón, Spain. She is author of *Sembrando ideales: Anarquistas españoles en Cuba* (2008) and several articles on the history of anarchism in Spain and Cuba published in refereed books and international journals, including “La reorganización del trabajo libre: Los anarquistas españoles y la difusión del ideal libertario en Cuba” (2010) and “Extranjeros perniciosos: El orden público y la expulsión de anarquistas españoles de Cuba (1899–1930)” (2007).

Robert Whitney is associate professor at the University of New Brunswick, Saint John. He is author of *State and Revolution in Cuba: Mass Mobilization and Political Change, 1920–1940* (2001), as well as several articles focused on diaspora studies, cultural identity, and transnational history, including “Observaciones sobre el Estado y la Revolución en Cuba, 1920 a 1940” (2001), “History or Teleology: Recent Publications on Pre-1959 Cuba” (2001), and “The Architect of the Cuban State: Fulgencio Batista and Cuban Populism, 1937–1940” (2000).
