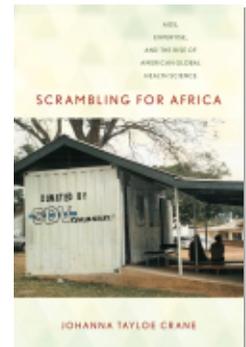

As a graduate student, my research and writing was supported by grants and fellowships from the Human Rights Center at UC Berkeley, the Philanthropic Educational Organization, the Institute for Health Policy Studies at UCSF, the University of California Universitywide AIDS Research Program, the National Science Foundation Science and Technology Studies Program, and the University of California Humanities Research Institute. The faculty and my fellow graduate students in the UCSF Department of Anthropology, History, and Social Medicine and the UC Berkeley Department of Anthropology created a fertile intellectual environment for work at the intersections of critical medical anthropology and science studies during the time I was there, which undoubtedly shaped the trajectory of my research.
