EMILY BOWLES currently serves as a Senior Lecturer in Women's Studies at the University of Wisconsin-Fox Valley and as the Assistant to the Chairs for the UW Colleges. She has published on Aphra Behn, Henry Fielding, and Frances Brooke. Her current research interests include satiric representations of femininity and sexuality in Mary Wortley Montagu's poetry.

SIMONE CHESS is an Assistant Professor of English and Women's Studies at Wayne State University. Her research interests are in Early Modern literary and cultural studies, with an emphasis on gender and sexuality. She has published articles and book chapters on the topics of bathroom activism, on ballads and Shakespeare, and on the role of oath-making in "murderous wife" ballads. She is currently completing a book project titled "Where's your man's heart now": Male to Female Crossdressing in Early Modern Literature.

LAUREN COKER is a doctoral candidate in English at Saint Louis University. She is currently completing her dissertation. RACHEL E. HILE is an Associate Professor in the Department of English & Linguistics at Indiana University-Purdue University Fort Wayne, where she also serves as editor of *Clio: A Journal of Literature, History, and the Philosophy of History*. She is the author of various articles on Renaissance poetry and drama, and editor [as Rachel Hile Bassett] of the collection *Parenting and Professing: Balancing Family Work with an Academic Career* (Vanderbilt University Press, 2005). She is currently working on a book about Edmund Spenser's influence on satirical poetry written in the 1590s and early 1600s in England.

NANCY J. HIRSCHMANN is Professor of Political Science at The University of Pennsylvania and Vice-President of the American Political Science Association. She is the author of many articles and books including *Gender, Class, and Freedom in Modern Political Theory*, *The Subject of Liberty: Toward a Feminist Theory of Freedom*, and *Rethinking Obligation: A Feminist Method for Political Theory*. She is also coeditor with Beth Linker of *Civil Disabilities: Theory, Citizenship and the Body* (forthcoming). She has held fellowships from American Council of Learned Societies, The Institute for Advanced Study, the National Endowment for the Humanities, and the Princeton University Center for Human Values.

ALLISON P. HOBGOOD serves as Assistant Professor of English and Women's and Gender Studies at Willamette University. Her fields of interest are Shakespeare and Early Modern literature, women's and gender studies, and disability studies. She has published articles in *Shakespeare Bulletin*, *European Romantic Review*, and *Disability Studies Quarterly*, a journal for which she coedited the special issue "Disabled Shakespeares." She is currently completing a book, *Passionate Playgoing in Early Modern England*, which investigates the feeling of spectatorship in English Renaissance theater.

MARCELA KOSTIHOVÁ is Associate Professor of English at Hamline University, where she teaches a range of courses in literary, cultural, gender, and film studies. Her research investigates changing structures of identity formation in central-eastern Europe represented in the postcommunist cultural sphere, ranging from literature, to theater, to film. She has published in national and international journals, and her first book, *Shakespeare in Transition: Political Appropriations in the Post-communist Czech Republic*, was published by Palgrave Macmillan in 2010.

MARDY PHILIPPIAN, JR., earned his Ph.D. at Purdue University and is currently Associate Professor of English at Simpson University, where he also serves as the Writing Center Director. He has published in the journals *Literature and Film Quarterly*, *Film Criticism*, *Prose Studies*, and *Forum for World Literature Studies*, and in the *Companion to Pre-1600 British Poetry*. In fall 2010 he joined the editorial board of *The Oswald Review: An International Journal of Undergraduate Research and Criticism in the Discipline of English*, published at the University of South Carolina Aiken.

LINDSEY ROW-HEYVELD is Assistant Professor of English at Canisius College. She has published articles on disability in early modern drama and is currently at work on a book titled *Disembling Disability in Early Modern England*, which explores fraudulent performances of the nonstandard body on and off the stage.

DAVID M. TURNER is Reader in History at Swansea University. He has written widely on the society and culture of early modern Britain and is the author of *Fashioning Adultery: Gender, Sex and Civility in England 1660–1740* (Cambridge University Press, 2002); he is also coeditor (with Kevin Stagg) of *Social Histories of Disability and Deformity* (Routledge, 2006). His most recent book, *Disability in Eighteenth-Century England: Imagining Physical Impairment* (Routledge, 2012), was the winner of the Disability History Association Outstanding Publication Award 2012.

SARA VAN DEN BERG is Professor of English at Saint Louis University. Her publications include *The Divorce Tracts of John Milton*, coedited with W. Scott Howard (2010); *Language, Culture, and Identity: The Legacy of Walter J. Ong, S.J.*, coedited with Thomas M. Walsh (2011); and essays on Milton, Jonson, and Shakespeare. Her current book project is a study of the cultural meanings of the dwarf body from 1500 to the present. She teaches courses in medical humanities, disability studies, and Early Modern English literature.

DAVID HOUSTON WOOD serves as Honors Program Director and Associate Professor of English at Northern Michigan University, where he focuses on sixteenth-century literature and culture. His recent work includes a monograph titled *Time, Narrative, and Emotion in Early Modern England* (Ashgate, 2009); a coedited collection of essays titled "Disabled Shakespeares," published in the journal *Disability Studies Quarterly* 29, no. 4 (Fall 2009); and numerous essays in journals such as *Shakespeare Yearbook*, *Renaissance Drama*, and *Prose Studies*.
