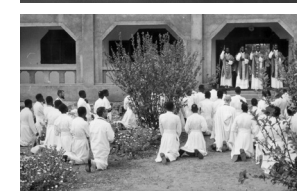
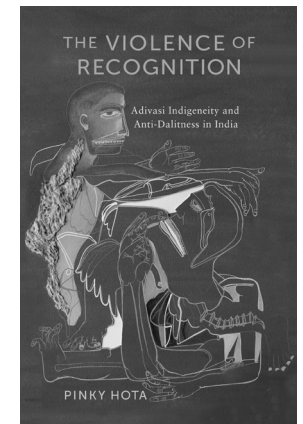
## The Violence of Recognition
